**Pre-Bid Construction Contract Checklist**

This document was developed to assist an applicant seeking funds for project construction under the Drinking Water State Revolving Fund (DWSRF) program. In order for the Department of Public Health (DPH) to consider work proposed to be conducted with a Construction Contract for approval and to determine compliance with DWSRF requirements, an applicant as a minimum, must satisfactorily complete this checklist and submit it to DPH along with one copy of a pre-bid construction contract (plans and specifications), and any other supporting documentation that may be warranted pursuant to applicable regulatory citations as identified in this checklist. Failure to provide the required information identified under this checklist may result in delay of approval of the project.

**Notes:**

- An applicant must obtain a written letter of **“Authorization to Award Construction Contract”** from the DPH prior to executing any construction contract pursuant to Section 22a-482-4(h)(3) of the Regulations of Connecticut State Agencies (RCSA).
- DWSRF applicant has certain regulatory responsibilities identified within Section 22a-482 of the RCSA. The applicant must read and adhere to the requirements as specified in the following provisions:
  - Change orders as stated in Section 22a-482-4(k) of the RCSA
  - Approval of project changes pursuant to Section 22a-482-4(p)5 of the RCSA
  - Protest requirements pursuant to Section 22a-482-4(o) of the RCSA
- An applicant and their consultant(s) are advised to review and be familiar with Sections 22a-482-2 through 22a-482-4 of the RCSA and other Statutory and/or requirements that may be applicable for a specific Public Water System or project, which may not be fully inclusive within this application.
- If an item on this checklist has not been submitted or included in the contract documents, an explanation must be submitted.
